How many UK homes have solar panels?

More than 1.3m UK homes - 4.1pc - now have solar panels installed, according to standards organisation MCS. A series of grants, loans and tax breaks over the last decade have encouraged uptake. The Feed-in Tariff (FIT) scheme, launched in 2010, allowed solar panel owners to sell electricity they generate back to their energy supplier.

Is residential solar scalable?
