What is 0% VAT on solar panels?

The 0% VAT on solar panels in the UK is a temporary measure, set to last until 31 March 2027. From 1 April 2027 onwards, the VAT rate on solar panel supplies will go back to the reduced rate of 5%, in line with the UK government's financial and renewable energy goals. Are solar panels VAT free?

Will VAT be scrapped on solar panels?

Scrapping of VAT on solar panels aims to reduce the cost of installing solar panels. The zero rate will run until 31 March 2027 and move to 5% VAT. Can I claim 0% VAT if I buy solar panels?

To work out how much you've saved in tax relief, simply take away the new tax you'll pay from the old taxes you would have paid: $\pounds 150,000 - \pounds 137,500 = \pounds 12,500$ In real terms, you would only be paying $\pounds 37,500$ for the solar panel installation when you minus your tax savings from the cost of the installation ($\pounds 50,000 - \pounds 12,500 = \pounds 37,500$).
