How do I make a complaint about a solar installation?

When making a complaint it is useful to have the following information: The date of installation may be present on installation paperwork and may also be on the energy efficiency measure, such as the loft installation, the boiler, or the Solar PV inverter. Please contact the ECO team (ECO.SAR@ofgem.gov.uk) to raise a Subject Access Request.

This dispute resolution process may be used by domestic consumers only. This form is used by the Renewable Energy Consumer Code as a summary record of your complaint and any action taken.

How do I complain to Citizens Advice?

They should have a formal complaints procedure process on their website or on your energy bills that explains how to do this. They can also explain their complaints procedure process if you contact them by phone. If you want to write to them or send them an email, you can use the Citizens Advice complaints letter template.

Who can I contact if I have a problem with my electricity?

Depending on what the problem is, you can complain to either your energy supplier (the company that provides your energy) or network operator (the company responsible for the pipes and wires that carry electricity and gas). If you are not sure who to contact, follow the instructions on our Find your energy supplier page.

In the highly competitive solar industry, companies often use aggressive marketing strategies to stand out, which can sometimes lead to exaggerated or inaccurate claims about the benefits of solar ...

You can complain to the energy ombudsman if you've already complained to your energy company and either: you're not happy with their decision. you've not been given a decision within 8 weeks. The energy ombudsman is independent and can: get the supplier to look at your complaint again. decide that the supplier made the right decision

First, call the solar company directly to try and resolve the issue. If you are unable to resolve your problem with the solar company, contact the Division. Complaint Process. Most of the Division's complaints are received informally by phone and are handled promptly. The PUCN's online Complaint and Question forms can also be used to submit a ...

Take time to review documentation the company provides to understand what type of solar panel system is being offered and any financing terms; Read the fine print carefully before signing a contract.
