Rooftop solar PV systems can be installed on any type of roof having sufficient load bearing capacity. ... Under the scheme, households will be provided with a subsidy to install solar panels on their roofs. The subsidy will cover up to 40% of the cost of the solar panels. The scheme is expected to benefit 1 crore households across India.

The maximum amount of money available for a solar panel installation loan is ₹7,500, which will cover the cost a typical 3.5 kWp solar PV system. The loan is completely interest-free, and is repayable across five years (if you borrow less than ₹5,000) or 10 years (if you borrow ₹5,000 or more).

The Smart Export Guarantee (SEG) is a scheme that requires energy suppliers to pay homeowners, landlords, and small businesses for the excess electricity generated by their solar panels and exported to the grid.
