What is a HTS code?

The first six digits of the HTS code identify all items in international trade and are the same for all countries that use the HTS. The last two or four digits are country specific. In many countries these last four digits provide the duty rate and balance of trade statistical reporting suffix for the imported goods.

How much does a solar panel weigh?

The item is equipped with three ByPass diodes to rectify the current and a waterproof box to protect the wires where they are connected. The item has 120 cells that are mounted in 20 rows with 6 pieces in each row. The assembled solar panel measures 1755 x 1038 x 35 mm and weighs 20 kg.
