Do I need planning permission to install a solar PV system?

This ammendment clasifies the installation of a residential solar PV or solar thermal system as 'permitted development' meaning planning permission is not requiredbefore work commences assuming that the installation fulfills the following conditions:

If the system is to be installed on an agricultural building a letter from a California licensed engineer or architect is required, stating the building is structurally sound to support the photovoltaic system. The City does not collect the building permit tax (associated with most construction projects) on the construction or installation of solar energy generation equipment. If the project is larger than just the solar installation, regular permitting charges will apply to the rest of the project.
