

Do you need planning permission to install solar panels on your roof?

An increasing number of people are investing in solar energy. More and more homes are having solar panels, or solar tiles, installed on their roofs. Of course, with such installations, the topic of planning permission and building regulations often comes to the surface.

Do solar panels comply with building regulations?

Your solar panel system must comply with building regulations in terms of structural integrity, electrical safety and fire safety. These regulations may vary depending on the size and type of the installation. It's advisable to work with accredited installers who are familiar with these requirements.

Are solar panels a legal requirement for new homes?

Even though installing solar panels on new builds is a great way to set new homes up with renewable energy from day one, it's not yet a legal requirement. One common problem is that developers don't use all the available roof space, resulting in a less effective solar panel system.

Are solar panels mandatory on new builds in the UK?

Solar panels aren't mandatory on new builds in the UK. However, other parts of the world have implemented requirements - in the EU, for example, solar panels will be mandatory on all new residential buildings by 2030.

Should solar panels be included in new buildings by 2025?

And a YouGov poll of 107 MPs in January 2024 revealed that 79% of them advocate for the inclusion of solar panels in all new constructions by 2025, signalling a push for further environmentally-friendly building regulations. In March 2024, the European Parliament approved a law requiring solar panels on all new residential buildings by 2030.

Are solar panels compulsory on new builds?

Unfortunately, solar panels aren't compulsory on new builds, but they have become a common way for developers to meet certain building regulations and make developments more sustainable. Many construction companies choose to install them in order to meet the required SAP (Standard Assessment Procedure) score for energy efficiency.

To figure out whether investing in a system is worthwhile, let's look at a simple example. If a battery storage system is expected to deliver 40,000kWh, then based on an electricity price of 30p/kWh you would expect that fitting it would save you a total of £12,000 over its warranted lifetime (40,000 x 15 / 100).
