Can I claim compensation for mis-sold solar panels?

If you feel you were mis-sold solar panels for your home you could claim compensation. Back in 2019, it was reported that the Financial Ombudsman Service had around 2000 complaints from unhappy customers who felt they had been mis-sold their solar panels, with more coming in every week.

Can I make a claim for mis sold solar panels?

What if I only used credit to pay for solar panels?

If you only used credit to pay for the deposit payment, under the Consumer Credit Act you will still be covered for the full purchase price of the solar panels. As long as the minimum deposit paid on credit was at least £100. Mr. D received over £9,000 after being mis-sold solar panels.

Can I recover money if my solar panels are faulty?

Every case is different, however, you may be able to recover up to 100% of your money as well as any other losses (for example, if the solar panels are faulty and not performing as well as promised). How do I make a claim for mis-sold solar panels?

Can I claim my solar panels if they go out of business?

So, if you funded your solar panels via a loan, credit agreement or by credit card, you may still be able to make a claim even if the original installers have gone out of business.

Do solar panels pay for themselves?

You get free electricity when the sun is out and any surplus generated is sold back to your energy supplier at a 'feed-in' tariff set by the Government. Homeowners are told the savings on offer mean that the panels pay for themselves. But, as David found out, this isn't always the case.

Solar panels are generally rated by their watt peak (Wp) value. When someone refers to their "440 panels", it typically means those panels have a watt peak power output of 440. Peak? A 440 Wp panel would produce 440 W of power under perfect conditions. The "peak" value represents the maximum output the panel can achieve.
