If you're moving into a property with solar panels installed as part of a "rent-a-roof" scheme, there should be a signed agreement between the homeowner and the rent-a-roof company. This could be a lease agreement, where the homeowner agrees to rent out their roof space to the company which installed the solar panels.

Renters and landlords can use the SunSPOT solar system calculator to see how rooftop solar may perform on a property. This is a good starting point for any conversation. Try the SunSPOT calculator. If the landlord owns the premises under strata title, they will not have authority to use the roof for solar.

A solar roof rental agreement is a contract between a property owner and a solar energy company in which the company installs solar PV panels on the roof of the owner's property and then pays the owner a fixed monthly payment in exchange for their roof space. So they are essentially renting out your roof space to make solar power more accessible.

The easiest way to go solar as a renter, of course, is to move into a building that already has solar panels installed on the roof. However, if solar panels for apartments don't have much of a ...
