



VAT rate on solar power generation income

What is the VAT rate for solar panels?

If the solar panels are purchased from one provider and installed by another, the higher rate is charged. Additionally, maintenance or repairs post-installation are also taxed at the standard rate. Prior to the 0% rate introduction, VAT for solar panels varied between 5% and 20%, based on specific conditions.

Do commercial solar panels cost VAT?

This means the bills paid for installing solar energy panels onto non-residential buildings will include VAT at the standard rate of 20%. Investing in a commercial solar panel installation is expensive, and many businesses opt to finance the project.

Do solar panels qualify for 0% VAT?

To qualify for 0% VAT, the solar panels must be newly purchased and installed on residential buildings. Installations must be carried out by approved installers to ensure compliance with government standards. Unfortunately, commercial properties generally do not qualify for the 0% rate.

Are solar panels VAT free?

Whether you're buying a standalone solar battery or getting a battery installed with a solar panel system, you'll benefit from the 0% VAT rate. This rule changed in February 2024 to include standalone storage batteries at the 0% VAT, regardless of whether you're getting solar panels at the same time. Is there VAT on solar panel income?

When will the VAT rate on solar panels revert to 5%?

The zero VAT rate on solar panels is set to continue until 31 March 2027, after which it will revert to a reduced rate of 5%, aligning with the government's long-term financial and environmental strategies.

Are solar panels tax deductible in the UK?

According to the UK government's list of Energy Saving Measures (ESMs), most solar photovoltaic (PV) panels installed on residential properties in Scotland, England and Wales (plus Northern Ireland, as of 1 May 2023) are exempt from VAT, meaning there's no VAT included in the purchase and installation costs.

The supply and installation of "energy saving materials", including solar panels, is currently subject to a reduced VAT rate of 5% in the UK. The European Commission is currently challenging this policy, arguing that the tax incentive goes beyond the scope of the law.

Before the Clean Export Guarantee was introduced in 2022, homes fitted with solar panels exported surplus electricity to the national grid for free. VAT is charged at 5% domestic installations and this is not reclaimable. No capital allowances (or other income tax relief) can be claimed on the cost of the solar installation. Any income from a domestic installation at one's home is tax-free. This includes both sales of exported electricity and any Feed in Tariff

While the installation of solar panels and batteries for commercial purposes generally falls under the standard rate of VAT (currently 20%), there are notable exceptions. New Builds and Conversions: Commercial properties that are new builds or undergoing conversion into non-residential use may qualify for the reduced 5% VAT rate.

In October 2019, the VAT charged on solar panels changed from a simple 5% rate to a complex calculation of 5 or 20% depending on personal circumstances and the breakdown of the installation cost.
